TO HELP YOU FILL OUT YOUR ENTRY COMPLETELY AND CORRECTLY:

Fill out as follows:

1. **Ear #** - The number or letters permanently tattooed in your animal's left ear.
2. **Breed** - The recognized breed of rabbit by the American Rabbit Breeders Association.
3. **Variety** - The recognized color of rabbit by the American Rabbit Breeders Association.
4. **Class** - The class of rabbits in age that your rabbit will be judged in. Circle only the correct age.
 - Jr. = rabbit under 6 months
 - 6 - 8 = rabbit between 6-8 months
(Examples: Californian, Satin, New Zealand, and French & English Lop)
 - Sr. = rabbit over 6 months of age
5. **Sex** - The sex of your rabbit showing - Buck (male) or Doe (female).
6. **Entry fee** - The amount for judging your rabbit depending on which show you are entering.
 - Youth = \$3.00 per rabbit
7. Make sure to sign your entry.
8. Any entry form not completed correctly will be returned to you.
9. Any entry accepted with complete but incorrect information on entry will NOT be changed at time of entry or judging.

For Entry Verification purposes, the Fair suggest sending a self addressed stamped envelope with your entry.
